4. Treasurer's Report

- a. Financial Report: Gord Holder presented the financial update to February 28, 2007, which is five months into this fiscal year. He reported that membership dues revenue is on target with the budget. Expenses for February are fairly light, and the expense figures to date are also on target as budgeted. Gord advised that since the financial report was prepared yesterday, we have received an invoice from the lawyer concerning the DLR file. Conferences expenses listed cover train tickets purchased for the April TNG Canada NRC meeting in Toronto. There is an amount of just over \$4,000 Receivable from Defence Fund, on the General Fund Balance Sheet which is largely CTV Ottawa bargaining expenses paid on behalf of the Defence Fund. The Defence Fund Balance Sheet shows the Guild long term investments assets at \$1,294,494.05, which is the market value as opposed to the book value of the assets.
- b. Toledo Newspaper Guild, Local 34043 Toledo Blade Lockout: TNG has requested financial support for the locked out newspaper workers at the Toledo Blade who have been locked out by their employer and are about to lose their health benefits. TNG is asking for \$800 per month for 3 months to pay for a worker's health insurance. Executive committee discussion and proposal to make a lump sum donation.

a. CTV Ottawa (CJOH)

Joanne Schnurr advised there will be someone coming from Toronto in April to speak with CTV Ottawa employees on the old and new pensions plans. Tony Cote is interested in attending that meeting on behalf of the Guild executive, and Joanne will confirm that with Delma Devoe in HR. Joanne advised that news director Scott Hannant plans to meeting with the Guild unit co-chairs (Joanne and Kimothy Walker) on a regular basis.

[a] Contract conciliation update: At the request of the Guild, lawyer Julie Skinner of Nelligan-O'Brien-Payne has filed for contract conciliation with the Quebec Minister of Labour. The parties are scheduled to meet on April 5, 2007. Dave Wilson and Claude L'Ecuyer will attend the meeting for the Guild, along with Julie Skinner. Lois Kirkup and Dave Wilson are to have

a conference call with the lawyer on April 3.

[a] Unit - Pay Equity Update: Lois Kirkup reported that the joint Pay Equity committee meetings have been postponed for the next couple of months.

After extensive executive discussion on the issue, it was decided to advise the district supervisors to talk to Debbie Cole or Lois Kirkup about their concerns.
- [d] Editorial Discipline: Lois Kirkup reported on a discipline meeting with management that she attended with a newsroom member who was assessed a three-day suspension for submitting improper expense claims.
- [e] New Local Lois Kirkup updated the executive committee on a small printing company in downtown Ottawa that wants to organize. There are currently six employees. Lois and Dave Wilson met with the owner of the company. After executive discussion, it was proposed that the ONG pursue this organizing potential and that Dave Wilson and perhaps one or two members of the executive committee meet with the employees to talk further.
