3. Secretary's Report

a. Executive Committee – good standing report.

Nancy Noel recorded that all executive members are in good standing. DLR Unit Chair Marc Laurin attended the executive meeting and his good standing status is restored.

b. Adoption of Minutes:

Executive discussion regarding updated information received from CWA about *Adopt-a-Family* concerning the locked out Toledo workers. Tony Cote proposed that the ONG make a further donation from the Special Projects Fund to the Toledo workers, to help pay health insurance costs, for example, for a six-month maximum period. Following executive discussion, it was decided that the Guild would bring this matter to the June 4 membership meeting for further action.

Tony Cote advised that Dave Rogers will be on sick leave for about six weeks following surgery on May 17; we will send a basket to Dave when he is home from the hospital.

4. Treasurer's Report

- a. Financial Report: Gord Holder presented the financial update to April 30, 2007, seven months into the fiscal year. Revenues are pretty well on target. Gord said that we will be over the budgeted amount for Interest Income, and that's a good thing. He advised that the dues per capita amounts payable to CWA Canada will increase slightly effective with the May/07 per caps, payable in mid-June. Conference expenses cover the national representative council meeting in Toronto. The Toledo strike donation (\$2,400 Cdn) has put us over budget on the Strike Donation line. Transfers to the Defence Fund in April amount of approximately \$3,400 primarily covers DLR contract conciliation costs. The Defence Fund Balance Sheet records the value of the long-term investments at \$1,295,552.60. There is an amount over \$8,000 Payable to General Fund, and Gord will transfer money from the Defence Fund in September, before the fiscal year end, to clear this amount. There was not a lot of change in value on the Defence Fund Income Statement for the month of April.
- b. 2007 Membership renewal Canadian Journalists for Free Expression:
 Notice was received from CJFE about annual membership renewal. The usual annual ONG donation has been \$200; \$25/membership and \$175/donation.

- c. OFL Strike Appeal IAM Local Lodge #2243: A strike appeal has been received from the OFL on behalf of IAM Local Lodge #2243, on strike against R-Theta Thermal Solutions in Mississauga. M/ by Gord Holder to send a \$50 strike donation. S/ by Joanne Schnurr. CARRIED.

5. Unit Reports

a. CTV Ottawa (CJOH)

Joanne Schnurr reported on a recent meeting with the company and a discipline letter that a member has had placed on their file. The ONG will grieve that the letter on file is excessive discipline.

b. **DLR International**

[a] Contract update: Marc Laurin reported that the four members voted in favour of the new contract. The new agreement is being translated. The graphics artist has left DLR and Marc advises that he will be replaced; also discussed co-op student.

c. Citizen

[a] Building Services Issues: Nancy Noel updated the executive committee on the followup to complaints filed by a mailroom cleaner. The Guild has received a copy of the detailed report prepared by the Citizen committee. The company met with managers to try to address the problems and to make sure that night supervisors are informed on how to handle situations that develop. Executive discussion; this appears to be a poisoned work environment and we need to keep an eye on things.

[b] Editorial - Miscellaneous: Online training is completed. People seem to have either caught on to posting stories online and are doing okay with that, or they are having difficulty with the work. Advised also of "turnaround" issues (Art. 8.5.5) where some members may not be properly receiving turnaround pay. Reported that a newsroom member applied for turnaround pay and was denied. Lois Kirkup will speak with the member and then with Pat Hyndman. If not resolved, this should be grieved.

Discussion about vacations and timebank – supervisors/managers should be keeping proper

records. General e-mail send out by Graham Green about timebank and the company plans to enforce the policy in the newsroom about employees not accumulating more than one week's worth of timebank (or two weeks' worth with the approval of a senior editor). Time in timebank is sacred - don't give it up; advise members that, if the company threatens to take away this time or forces them to take time off, they should discuss this with a Guild executive member.

[c] Editorial - Days & Nights Shifts: The Guild has become aware that for about the last three weeks a page designer has been working a mix of day and night shifts in the same week. At the request of the member, he is working Monday night, and then day shifts for the balance of his week. Guild would have to agree to special request to allow the mix of shifts. Recent online training also complicated days/nights shift combinations in the same week. Executive committee discussion. Guild will send a letter from the Citizen unit leader to the company advising that scheduling of days/nights in the same week is a violation of Article 8.1.6 of the contract.

[d] Editorial - Photo Correction: Tony Cote updated the executive on the situation of a misidentified photo that appeared on the front of the City section in today's paper. Tony talked with Graham Green this morning. The case involved a child molester and the wrong person was identified in the photo. This is the third situation in the past six months in which Merlin system information was incorrect and led to a major error. The Guild has made suggestions to the company in the past about how to improve Merlin and the photo system; cutlines are a problem.

[e] Editorial - Corbett resignation: Tony Cote reported that Ron Corbett, who was to start at his new rewrite chief job on Monday, instead resigned that day from the Citizen.

The executive committee can always reaffirm actions/results at an executive meeting to complete the process.
