4. Treasurer's Report

a. Financial Report: Gord Holder provided the financial update to fiscal year-end September 30, 2007. Membership dues amount is higher than normal amount as we've accrued for the

estimated amount of dues to the end of the month. Total Revenue for the year is about \$18,000 more than budgeted for as we estimated conservatively last year.	/2

There is a negative amount shown on the Conference and Meetings lines, because of adjustments made to accrued lost time that reflect charges on the Citizen quarterly invoice. The Rent expense for September is less than normal because Minto sent us a rebate/refund cheque for common area expenses we have been overcharged for the period ending December 2006. The Guild Awareness figure reflects value of items distributed to new members in the past fiscal year. Gord reported the Guild has paid \$7,500 plus GST to date for the Local History project, with one more invoice to come. The ONG was authorized by the membership to spend up to \$15,000 on the project, but GST wasn't included in the project quote or the motion. The ONG will need to bring the Local History Project approval back to the December 12 General Membership meeting to approve the additional GST costs. Gord advised we have received a cheque from Wood Gundy to cover expenses paid by the General Fund on behalf of the Defence Fund, except for the additional amount of \$4.32 on a legal bill.

Gord reported that September was a good month for the bond market and the Defence Fund long-term investments value is recorded at \$1,288,475.44. The Defence Fund Income Statement numbers indicate expenses totaling \$12,401.09 and an increase in value of \$22,848.82, resulting in a Net Income figure of \$10,447.73.

c. Delta Reprographics

Lois Kirkup said we have been unable to get the parties together for mid-October as intended. She will contact CWA/SCA Canada rep Dan Zeidler and we will check out dates in early November for bargaining the first contract.

d. Citizen

- [a] RS&S Part-time CSR Hours Without Prejudice Agreement: The Guild sent a letter September 10 to Sue Armstrong requesting to renew the current agreement to July 20, 2008, the contract expiration date. Lois Kirkup will check to see if she has received a response from the Citizen.
- [b] RS&S Discipline Letter: Debbie Cole reported that she talked further with Sue Armstrong; the matter is settled with no further changes made to the company letter.
- [c] Unit Pay Equity Review: Lois Kirkup reported that the parties met on September 24 and agreement was reached on the Financial Services B-3 positions. Settlement was also reached on the B-4 Switchboard operator position, with the parties agreeing that member will be compensated at the B-3 rate of pay for 2.5 hours per day. The parties will deal with the Reader Sales & Service department next. A meeting is scheduled for the morning of November 1. Lois Kirkup and Debbie Cole will meet before that date.
- [d] Editorial Pages to Hamilton; Guild requested meeting with Publisher and Editor-in-Chief:

Lois Kirkup met with Jim Orban and Scott Anderson. Scott Anderson will be holding three rounds of meetings with each department starting October 15 and a town hall meeting will be held at 8:30 a.m. on October 16. It's reported that up to one-half the paper will be going to Hamilton; it's still to be seen what will work. People are leaving and are not being replaced. Extensive discussion; we need to keep people engaged and involved. Guild should send a letter to the membership after the dust settles to let members know that their backing and attendance at meetings matters and makes a difference.

- [e] Editorial Employee Survey: Newsroom member Jackie Beingessner submitted a series of questions to Lois Kirkup that the Guild could ask members to complete to get their input on the newsroom changes and generally how things are work, or not working. Survey questions could be emailed to all editorial department members.
- [f] Unit New Manulife Benefits Claim Form: The ONG sent a letter to the company September 26 advising of its concerns with the new claim form; no response yet from the company.
- [g] Editorial Online Editor Job Classification: Lois Kirkup advised that she is working on completing the Pay Equity questionnaire for her position.
- [h] Editorial Parking Court House Reporter: The Guild filed a grievance when the company advised it will not cover the parking expenses for the reporter working at the Court House. The Citizen had provided a parking spot at the Court House, but gave notice it would discontinue paying the parking charges effective October 1/07; no response to the grievance letter yet.
- [i] Night Differential Montreal: Just a heads up that CanWest is trying to cut back / prorate the night differential in Montreal; watch for this here.
