SUMMER 2009 FYI UPDATE



⊃ The June 9 ONG General Membership meeting was held at noon hour in the ONG office. Members were brought up-to-date and talked about the Canwest situation. Also discussed were Citizen vacation policy issues and the newsroom reorganization. The ONG/Ottawa Citizen Request to Withhold Bylines arbitration hearing started May 1.

⊃ The September 16 General Membership meeting was held at noon hour in the Citizen Conference Centre. The accounting firm of Bouris, Wilson was appointed to conduct the audit of the Guild's financial statements for the fiscal year October 1, 2008 - September 30, 2009. The membership approved the proposed budget for 2009/2010. Also discussed were ideas to help the ONG mark its 60th Anniversary on December 1, 2009. Due to the resignation of Jake Rupert, there is a vacant Member-at-Large position on the executive committee. If you are interested in this position, please contact a member of the ONG executive.

⊃ CTV Ottawa

Challenging staffing issues continue for the CTV Ottawa unit. The Guild was to meet again with management in September to assess staffing levels and the impact on operations. Unit reps have also asked for regular newsroom meetings.

\supset Delta Reprographics

The Guild tried unsuccessfully to set up an after work meet and greet with Delta employees in June and will try again to arrange an informal get-together after work this fall. An election needs to be held for a Delta Unit Leader.

\supset DLR International

A letter of understanding was signed last spring to extend the DLR contract (which expired in November 2008) for one year until November 17, 2009. The parties agreed they will meet on or around the November expiry date to bargain new terms for the agreement. The DLR group also needs to elect its Unit Leader to serve on the executive committee.

⊃ Ottawa Citizen

Canwest update: Company restructuring/debt extensions/lending talks and financial deadlines appear to have been the norm. The next Canwest deadline is September 30. Guild Locals in the Canwest chain have been participating in regular CWA/SCA Canada conference calls.

Request to Withhold Bylines arbitration: Lois Kirkup attended the continuation of hearings that wrapped up on September 22. Final arguments of the parties will be submitted in writing to the arbitrator.

Agreement between Canwest and Quebecor means the Ottawa Citizen will take responsibility for home delivery, but the Ottawa Sun will handle dealer accounts, starting later this fall. ONG executive members expressed concern about the impact on Guild members, and eventually the Citizen itself, and met with company management earlier in September.

A couple of discipline grievances for a Building Services member remain ongoing. One file involves a suspension for lateness/attendance and the second grievance concerns an unpaid sick leave day.

 $\rm H1N1$ - ONG Citizen Joint Health & Safety Rep Terry Garner advises that the Citizen is implementing flu preventative measures for counter-area staff and will distribute packs to all employees. More hand sanitizer stations will also be installed throughout the building. The next H&S committee meeting is scheduled for the end of September.
