a. Executive activity since last general meeting: President Lois Kirkup reported that there has been little activity on the grievance/arbitration front. A second day of hearings on the Citizen byline arbitration hearing had been held in September and written final submissions had been made by both sides; a decision is pending. A re-organization in the Citizen RS&S department had led to a cut in hours for part-time members.

With regard to the financial status of Canwest, CWA/SCA Canada and its locals remain ready to file required documents in the event that Canwest files for CCAA protection, which is expected to occur at any time. CWA/SCA Canada and local reps met with Canwest officials, who said there was a need for concessions, but refused to be specific and did not offer anything in return. In response to a question, members were told that funds in the Canwest pension plan were safe in the event of a CCAA filing/ bankruptcy, but not any shortfalls that existed. Lois Kirkup said Canwest had pledged to make required payments to address pension shortfalls. ONG will hold a special membership meeting if/when Canwest files for CCAA protection.

Guild members were reminded of the ONG 60<sup>th</sup> Anniversary reception today from 3-7 p.m. in the Citizen Conference Centre.

b. Presentation of TNG-CWA 25 Year Pins
