# MINUTES OF GENERAL MEMBERSHIP MEETING Wednesday, December 14, 2011

1. Membership meeting called to order by Debbie Cole at 12:06 p.m.

## 2. Adoption of Agenda

## 3. Adoption of Minutes

## 4. **President's Report**

(a) Debbie Cole was elected President at the September general meeting, completing the term of Lois Kirkup, who was on leave of absence. As well, Rob Bostelaar had been elected as a member-at-large. The executive had appointed Jeff Parks as vice-president on an interim basis. All terms ends Dec. 31. Elections were to be held later at this meeting.

Two members on LTD had returned to work recently at the Citizen. Some issues had developed, but ONG executive is committed to ensuring that members' rights are protected.

A temporary full-time employee in Citizen Editorial had been hired as a permanent employee.

The Citizen letters editor position had been in flux. A member was in the position on a temporary basis, which had been extended, and the position was being reviewed.

(b) Presentation of TNG-CWA 25 Year Pin: Norm Provencher (Citizen/Editorial) was out of town so executive was to arrange presentation of his 25-year membership pin at another time.

#### 5. Financial Report

(a) Update: [see attachment] President/Treasurer Debbie Cole reported that there was nothing surprising about the first two months of the current fiscal year. The Defence Fund was valued at \$1.568 million, mostly invested in fairly liquid GICs, as of Nov. 30.

(b) Audit Report - Financial statements for 2010-2011:

Copies of audited financial statements are available. Executive members had passed a motion confirming the draft statements, as per new accounting rules. No changes were made to the statements by the auditors. A variance in arbitration costs (downward) from the previous fiscal year was attributed to the awarding of legal costs in one of the Citizen LTD cases, which lowered costs for past year.

7. Proposed Bylaws Change - Article 5.06

Article 5.06 - All the Local Officers (President, Vice-President, Secretary, Treasurer) shall be signing officers on Local accounts. The Executive Committee may designate ONE OTHER EXECUTIVE MEMBER AND one staff person to also hold signing authority. The Local Officers (DELETE)and(END DELETE), (ADD COMMA) any designated EXECUTIVE MEMBER AND staff person shall meet within two weeks of any change in the officers, DESIGNATED EXECUTIVE MEMBER or designated staff person to sign the requisite papers. All persons with signing authority shall be bonded in a sum to be set annually by the Executive Committee. Amendment: M/ by Tony Cote. S/ by Chris Vernell. That the phrase "may designate one other executive member" be changed to "shall designate one other executive member". Accepted as friendly amendment. CARRIED.

# 9. Ottawa Citizen Unit Meeting

Citizen Unit meeting called to order at 12:33 p.m.

(c) Tony Cote, former Citizen Unit member and the Retiree at-large member of the executive, made a brief presentation on the Congress of Union Retirees of Canada health-care initiative in Ottawa on Nov. 30-Dec. 1.

Day 1 included workshops and a presentation on the health care system by Roy Romanow. Day 2 featured meetings with 110 MPs and Senators to lobby them on health-care reform. The national health care accord between the federal and provincial governments expires in 2014 and is being renegotiated. The CURC campaign seeks to improve the accord, such as by adding pharmacare. A similar program last year dealt with pension issues.

CURC (spearheaded by Jerry Jones, retired Canadian Media Guild member) is trying to get more retirees involved in the chapter. Efforts include looking at offering services/benefits such as discounts on various services and programs. One option being considered is piggybacking on the Union Benefits program already available to current union members.
